

**TERMS & CONDITIONS FOR BIOFINITY® TOUCH ‘N GO  
CASH BACK PROMOTION**

By entering or participating in this Biofinity® Touch ‘N Go Cash Back promotion (“**Promotion**”) organized by CooperVision Contact Lens (Malaysia) Sdn. Bhd. (“**CV**”), you agree to these Terms & Conditions (“**Terms & Conditions**”). A Privacy Notice attached to or otherwise provided in connection with these Terms & Conditions should be regarded as part of these Terms & Conditions.

*Redemption Process*
